 - ❖ UBUNTU FARMING & CROP PRODUCTION CC: *VALID COPY OF SOCIAL SECURITY GOOD STANDING CERTIFICATE AND AFFIRMATIVE ACTION COMPLIANCE CERTIFICATE* - Not provided. The bidder however didn't initial all the pages of the bidding document as required by additional criteria, hence the bidder was disqualified for further evaluation.
 - ❖ ELON STUD FARMING: *VALID COPY OF TAX GOOD STANDING CERTIFICATE, VALID COPY OF SOCIAL SECURITY GOOD STANDING CERTIFICATE AND AFFIRMATIVE ACTION COMPLIANCE CERTIFICATE* - Not provided. The bidder however didn't initial all the pages of the bidding document as required by additional criteria, hence the bidder was disqualified for further evaluation.

EVALUATION

Four (4) companies/bidders that conform to the requirements of obligatory documents were further evaluated on the **BIDDING PRICES**, where the lowest substantially responsive bid in accordance with the Public Procurement Act, Act 15 of 2015, will be selected and recommended to Procurement Committee. Their bidding prices were as follow from the lowest to the highest bidder

- As per the above table indicating the bidders prices and with the evaluation approach being "lowest substantially responsive bid" in accordance with the Public Procurement Act, Act 15 of 2015, and based on the evaluations done by the ad hoc bid evaluation committee it is herewith recommended that the bid, as submitted by **Andjamba Construction CC**, is accepted and that the contract be awarded to them with a bid amount of **N\$ 552,000.00** (Five Hundred and Fifty Two Thousand Namibian Dollars), which amount includes 15% VAT and transportation fees.
