7. Recommendation

Based on the criterion on page 21 of the Bidding document, Section III - Evaluation criteria 1. of I) 'In order to distribute equity fairly Erongo Regional Council will award only one constituency per contractor. No multiple awards will be made to a bidder/ Contractor'. The bid Evaluation committee thus recommends different bidders to different constituencies.

KKK Trading and Construction cc is recommended for Daures Constituency for an amount of N\$140,793.33; Hammwertime Trading & Construction for Walvisbay Rural Constituency for an amount N\$83,290.00; Malla Trading cc is recommended for Karibib constituency for the amount of N\$123,459.40
